

16. CERTIFICATION CHALLENGE-SKIP TO EVALUATION

16.1 Football Canada Challenge Policy:

The NCCP program allows individuals to challenge the process.

What does this mean?

This means that you can skip the workshop sessions and go directly to the evaluation process.

Who is eligible for this?

Competition-Introduction: Position Coach

- 5 years experience as a Positional Coach
- Letter from organization supporting coaching history
- Completion of Online Make Ethical Decision Evaluation
- Completion of Safe Contact Workshop

Competition-Introduction-Coordinator

- 10 combined years experience as a Position coach and Coordinator (Minimum 3 years Coordinator)
- Letter from organization supporting coaching history
- Completion of Online Make Ethical Decision Evaluation
- Completion of Safe Contact Workshop

Competition-Introduction Head Coach

- 15 combined years experience as a Position coach and Coordinator (Minimum 3 years Coordinator and 2 years head Coach)
- Letter from organization supporting coaching history
- Completion of Online Make Ethical Decision Evaluation
- Completion of Safe Contact Workshop

Competition Development

- 10 years coaching experience at the CJFL/CEGEP/CIS/FOOTBALL CANADA CUP/INTERNATIONAL
- Letter from organization supporting coaching history
- Completion of Online Make Ethical Decision Evaluation
- Completion of Safe Contact Workshop

How do I do this?

Contact your Provincial Football Association to find out when you can set up an evaluation.

How much will it cost?

The cost of doing this will be equivalent of the cost of taking the workshop plus the cost of the evaluation. Basically it will cost the same as if you were to attend the workshop.

Note: All of the materials associated to NCCP Football workshops will also be provided to those who choose to challenge the process.

What happens next?

An evaluator will evaluate whichever evaluation procedure is necessary for the context in which you are challenging. An evaluation sheet shall be completed and given to the challenger. Should the challenger receive a successful evaluation then they will be deemed certified.

What if I do not pass?

The challenger will then have to start the process over. They will not be able to challenge the process a second time around. They then must attend the workshop before going through the evaluation process in which they will have to pay for re-evaluation.
