<b>4. Medical Treatment.</b> I/We authorize the employees, representatives or agents of to obtain or consent to any necessary treatment or medical care to the Minor in the event of a medical emergency or trauma occurring to the Minor during the practices or games	
<b>5. Release.</b> In consideration of Minor being allowed to participate in the football events, I/We, and on behalf of Minor, do hereby completely forever release and covenant not to sue OFA, the, and their employees, sub-contractors, agents, affiliates, members, officers, directors, and respective successors and assigns (collectively known as "Releasees"), from any and all present and future claims, causes of action, damages, costs, expenses, and attorneys' fees for property damage, bodily and personal injury, illnesses, paralysis, and/or death arising out of Minor's participation in the practices and games, ("Claims"), including as a result of any of the Releasee's ordinary negligence.	
<b>6. Indemnification.</b> I/We hereby acknowledge and agree to fully indemnify and hold forever harmless the Releasees against loss from any and all: (i) Claims; (ii) any and all present and future claims, causes of action, damages, costs, expenses, and attorneys' fees which may hereinafter or at any time be made or brought against Releasees by any person or entity as a result of property damage, bodily and personal injury, illness, paralysis, and/or death to the Minor arising out of the Minor's participation in the practices and games; and (iii) any and all present and future claims, causes of action, damages, costs, expenses, and attorneys' fees which may hereinafter or at any time be made or brought against Releases by any person or entity who claims to have been damaged as a result of Minor's negligence in connection with the Minor's participation in the football events.	
7. Media Release. I/We hereby authorize and grant, and their successors and assigns, the irrevocable right and permission to photograph, record, copy, reproduce, broadcast, transmit, and/or exploit throughout the world, by any present or future method or means, the Minor's participation in the football events.
